COMPLETION OF PLACING

The Board is pleased to announce that the condition set out in the Placing Agreement has been fulfilled and completion of the Placing took place on 3 March 2014 in accordance with the terms and conditions of the Placing Agreement.

An aggregate of 77,000,000 Placing Shares, representing approximately 12.56% of the issued share capital of the Company as at the date of this announcement, have been successfully placed to not less than six Placees who and whose ultimate beneficial owners are Independent Third Parties. The Company received net proceeds of approximately HK\$12.56 million from the Placing.

Reference is made to the announcement of Merdeka Resources Holdings Limited (“Company”) dated 21 February 2014 (“Announcement”) in relation to, amongst other things, the Placing under the General Mandate. Capitalised terms used in this announcement shall have the same meanings as defined in the Announcement unless otherwise stated.

The Board is pleased to announce that the condition set out in the Placing Agreement has been fulfilled and completion of the Placing took place on 3 March 2014 in accordance with the terms and conditions of the Placing Agreement.
