CHANGE OF COMPANY NAME AND STOCK SHORT NAME

Reference is made to the announcements of Merdeka Mobile Group Limited (formerly known as “Merdeka Resources Holdings Limited”) (the “Company”) dated 17 February 2014 and 21 March 2014, and the circular of the Company dated 25 February 2014 (the “Circular”) in relation to the Change of Company Name. Unless otherwise defined, terms used herein shall have the same meanings as those defined in the Circular.

CHANGE OF COMPANY NAME

The Board is pleased to announce that the change of the English name of the Company from “Merdeka Resources Holdings Limited” to “Merdeka Mobile Group Limited” and the adoption of the Chinese name “萬德移動集團有限公司” to replace “萬德資源集團有限公司” for identification purposes took effect on 8 May 2014.

Following the passing of the special resolution approving the Change of Company Name by the Shareholders at the EGM held on 21 March 2014, the Certificate of Incorporation on Change of Name certifying the change of the name of the Company from “Merdeka Resources Holdings Limited” to “Merdeka Mobile Group Limited” was issued by the Registrar of Companies in the Cayman Islands on 24 March 2014. The Certificate of Registration of Change of Corporate Name of Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 22 April 2014 confirming the registration of the new name of the Company in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong) with effect from 22 April 2014.


EFFECT ON CHANGE OF COMPANY NAME

The Change of Company Name will not affect any of the rights of the holders of securities of the Company. The existing certificates of securities in issue bearing the former name of the Company shall, after the Change of Company Name, continue to be evidence of title to such securities and the existing share certificates of the Company will continue to be valid for trading, settlement, registration and delivery purposes. As such, there will not be any arrangement for exchange of the existing share certificates of the Company for share certificates bearing the new name of the Company. With effect from 8 May 2014, all new share certificates of the Company will be issued under the new name of the Company.

CHANGE OF STOCK SHORT NAMES

The Board also announces that the English and Chinese stock short names for trading in the Shares on the Stock Exchange will be changed from “MERDEKA RES” to “MERDEKAMOBILE” and from “萬德資源” to “萬德移動” respectively with effect from 8 May 2014. The Shares will be traded on the Stock Exchange under the new stock short names with effect from 9:00 a.m. on 8 May 2014. The stock code of the Shares will remain as “8163”.
