Reference is made to the circular (the “Circular”) of Merdeka Mobile Group Limited (formerly known as Merdeka Resources Holdings Limited) (the “Company”) containing, among others, a notice of extraordinary general meeting of the Company to be held on 17 June 2014 (the “EGM”) dated 28 May 2014. Unless the context otherwise requires, capitalized terms used in this announcement shall have the same meanings as those defined in the Circular and the notice of the EGM (the “EGM Notice”).

The Board is pleased to announce that all the resolution proposed was voted by the Shareholders by way of poll at the EGM held on 17 June 2014.

The Branch Share Registrar of the Company, Tricor Tengis Limited, was appointed as the scrutineer at the EGM for the purpose of vote-taking.

As set out in the Circular, each of Mr. Cheung Wai Yin, Wilson, the Chairman, Chief Executive Officer and an executive director of the Company, and Mr. Lau Chi Yan, Pierre, the Managing Director and an executive Director of the Company, and their respective associates have abstained from voting in favour of the ordinary resolution. As at the time of the EGM, Mr. Cheung Wai Yin, Wilson and his associates hold 52,797,500 Shares representing approximately 8.62% of the issued share capital of the Company, and Mr. Lau Chi Yan, Pierre and his associates hold 2,125,000 Shares representing approximately 0.35% of the issued share capital of the Company. As at the time of the EGM, the total number of issued and fully paid up Shares was 612,850,215 Shares. The total number of Shares entitling the Independent Shareholders to attend and vote for or against the ordinary resolution was 557,927,715 Shares. There was no Share entitling the Independent Shareholders to attend and vote only against the ordinary resolution.

Save as disclosed above, none of the Shareholders have stated their intention in the Circular to vote against or to abstain from voting on the resolution at the EGM.

As more than 50% of the votes were cast in favour of the ordinary resolution proposed at the EGM, it was duly passed.
