CHANGE OF COMPANY NAME

The Board is pleased to announce that the change of the English name of the Company from “CCT Resources Holdings Limited” to “Merdeka Resources Holdings Limited” and the adoption of the Chinese name “萬德資源集團有限公司” to replace “中建資源集團有限公司” for identification purposes took effect on 5 November 2010.

Following the passing of the special resolution approving the Change of Company Name by the Shareholders at the EGM held on 5 November 2010, the Certificate of Incorporation on Change of Name certifying the change of the name of the Company from “CCT Resources Holdings Limited” to “Merdeka Resources Holdings Limited” was issued by the Registrar of Companies in the Cayman Islands on 5 November 2010. The Certificate of Registration of Change of Corporate Name of Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 25 November 2010 confirming the registration of the new name of the Company in Hong Kong under Part XI of the Companies Ordinance (Chapter 32 of the Laws of Hong Kong) with effect from 25 November 2010.

CHANGE OF STOCK SHORT NAMES
